Centerville Small Arms Range Rules: Ver May 2016

- 1. Whenever someone is at the range, the range flag at the 300 yard firing line will be flown.
- 2. NO LOANING OF RANGE KEY!

Any member who duplicates or loans his range key or membership card shall be subject to expulsion.

- 3. PAPER TARGETS ONLY! may be used on the range. NO glass, plastic, metal, or junk. No shooting at cans, bottles, jugs etc is allowed. No shooting at target uprights, target frames, number board posts, or other structures other than designated targets. Use of metal targets is allowed only if the target type has been specifically approved in advance by the board. No shooting at the Conexes, Porta-Potties, or any other semi permanent structure which may be present.
- 4. NO SHOOTING ON SUNDAY! unless it is approved by the City Council and the board!
- 5. ALL SHOOTERS MUST REMOVE THEIR USED TARGETS, EXPENDED BRASS AND TRASH.
- 6. NO USE AFTER SUNSET or fires or camping, except with prior approval of the board.
- 7. NO SHOTGUN, AUTOMATIC RIFLE, OR 50 BMG USE
- 8. THE WEB SITE WWW.CENTERVILLESMALLARMS.ORG WILL BE

CHECKED for announcements on the main page, and the range schedule page every time before going to the range!

- 9. The Red Range Flag at the 300 yard firing berm will be flown whenever the range is in use. The last one leaving is responsible for lowering the flag.
- 10. No vehicles allowed in target impact area
- 11. No firing outside of the 3 range backstop areas located just behind each 2 target frame pits, or the berm directly in front of the 200/300 pits is permitted. This means no shooting to the east, and no shooting by the upper gate.
- 12. Cleanup following a shooting session is mandatory. If you bring it in, take it out. If you use practice target frames, put them away when you are done.
- 13. No Dumping. Take out everything you bring in.
- 14. No Off Road ATV or Motorcycle riding on the range.
- 15. Scheduled events (Competitions, work parties etc) have priority for range use. (See web site for schedule)
- 16. Range Fee for all guests must be paid in order to use the facilities. The Club member is responsible for collecting the daily use fee of \$2.00 for each guest. Place these fees in Envelope, write member and guest name on envelope, place in can.
- 17. All persons 21 and under must have an adult member present at all times while shooting.
- 18. The range will be closed for all other uses when scheduled for a Junior practice or competition.
- 19. Use of the range is at the sole risk of the user, who shall be solely responsible for such use.
- 20. No Firearms will be handled while persons are forward of the firing line.
- 21. No dogs are allowed on the range
- 22. All wildlife shall be protected on the range.
- 23. Incendiary, tracer, or armor piercing ammunition shall not be discharged within the range facilities.
- 24. Membership cards must be available or conspicuously displayed when using the range. Persons, other than Centerville Police Officers, not displaying membership cards will be asked to show their cards or leave the range until their cards can be presented.
- 25. Any person disregarding rules, or violating safety procedures or range procedures WILL BE REMOVED FROM THE RANGE AND MAY BE EXPELLED FROM MEMBERSHIP! MEMBERS ARE RESPONSIBLE FOR THEIR GUESTS.
