I understand that target practice, use of firearms, work on club facilities, engaging in work projects and club service and other club activities may be dangerous activities and result in exposure to lead and other metallic compounds and pose a risk of injury or death to the user, and other members of the Club and the general public. I HEREBY RELEASE CENTERVILLE SMALL ARMS ASSOCIATION, ITS OFFICERS, TRUSTEES, AND OTHER MEMBERS, the NRA, the CMP and the City of

Centerville from any and all liability arising directly or indirectly from the use of the range by myself and my guests, including arising from the simple negligence of the club, the officers, trustees, and other members; that I consent to a check by the Club of my

references and other personal information.

I further understand that my membership is dependent upon knowing and following the NRA safety and Centerville Range rules, and that I will be responsible for 5 hours of work at the range during the year as a condition of membership. These 5 hours of work can be done during scheduled work days as posted on the Range Schedule, or by contacting Ryan Kozole csaorange@gmail.com. If you have not recorded you 5 hours of work at the range an \$50 fee will be required.

Centerville Small Arms Range Rules:

1. THE WEB SITE WWW.CENTERVILLESMA LLARMS.ORG WILL BE CHECKED for announcements on the main page, and the range schedule page every time before going to the range! Scheduled events have priority for range use. If law enforcement signs are out do not go through the gate or up the road. Call dispatch at 801-292-8441 request to talk to a Centerville officer about the range, they will call you for an update.

2. NO LOANING OF RANGE KEY! Any member who duplicates or loans his range key or membership card shall be subject to expulsion.

3. STEEL TARGETS. Cautious use of steel targets is permitted at the member's sole risk. Centerville Small Arms Association assumes no responsibility for an individual member's steel-target use. Members are strongly advised to keep a suitable fire extinguisher immediately available for sparks or fire and to exercise sound judgment. **NO STEEL OR STEEL-CORE AMMUNITION IS ALLOWED ON THE RANGE.**

4. NO SHOOTING ON SUNDAY!

5. NO SHOOTING BEFORE 8:00 am

6. ALL SHOOTERS MUST REMOVE THEIR USED TARGETS, EXPENDED BRASS AND TRASH, and Put away anything they got out of the target storage containers.

7. NO USE AFTER SUNSET. No Fires, No Camping.

8. NO SHOTGUN, AUTOMATIC RIFLE, or LARGE CALIBERS (CheyTec or 50 BMG) will be fired.

9. Incendiary, tracer, or armor piercing ammunition, or exploding targets shall not be used.

10. The Red Range Flag at the 300 yard firing berm will be flown whenever the range is in use. The last one leaving is responsible for lowering the flag.
11. No bullet impacts outside of the 3 range backstop areas located just behind each of the 2 target frame pits, or the berm directly in front of the 200/300 pits are permitted. This means no shooting to the east, and no shooting by the upper gate.
12. No Firearms will be handled while persons are forward of the firing line.
13. Range Fee for all guests must be paid in order to use the facilities. The Club member is responsible for collecting the daily use fee of \$5.00 for each guest. Fees go in "Fee Can" in 200 Yard Practice Container.
14. Use of the range is at the sole risk of the user, who shall be solely responsible for such use.
15. All persons under 21 must have an adult member present at all times while shooting.
16. No Off Road ATV or Motorcycle riding on the range.
17. No dogs are allowed on the range.
18. All wildlife shall be protected on the range.
19. Membership cards must be available or conspicuously displayed when using the range. Persons, other than Centerville Police Officers, not displaying membership cards will be asked to show their cards or leave the range until their cards can be presented.
20. Range may not be used for any commercial ventures.
21. Any person disregarding rules, or violating safety procedures or range procedures **WILL BE REMOVED FROM THE RANGE AND MAY BE EXPELLED FROM MEMBERSHIP! MEMBERS ARE RESPONSIBLE FOR THEIR GUESTS.**
